## <u>Oral statement</u> Check against delivery

Mr. President,

We would like to thank the Special Rapporteur for the presentation of his report on the gold mining issue.

We are glad to realize that the report address the case of the Yanomami peoples. In fact, we have been carefully monitoring and working with Yanomami representatives to engage with the Special Rapporteur and denouce the human rights violations committed by the so-called garimpeiros. We call upon the Brazilian government to implement all the necessary measures to put an end to illegal gold mining and protect the rights of the Yanomami peoples.

We take the opportunity of this debate to call the attention of this Council about another representative case: the dismentling of the NAe São Paulo ship, transporting toxic wastes, which was travelling from Brazil to Aliaga shipyard, in Turkey.

Local social mouvements were concerned about that ship leaving Brazilian territorial waters despite the interim injuncion issued by the federal court. For months the Turkish government tried to convince the public opinion that the ship presents no hazard for public health in general or dock workers specifically.

Moreover, the people of Izmir, more than 50 trade unions, Turkish and Brazilian confederations, professional and grassroot organizations, as well as ecology movements organized daily protests against the arrival of that ship in Aliağa – Turkey. Alerts delivered by the Association of asbestos experts (ASUD) in Turkey were simply ignored. However, the Turkish government finally cancelled the import approval due in no small part to the largely supported «We will stop the death ship» campaign.

CETIM voicing the concerns expressed by the aformentionned campaign<sup>1</sup>, which transformed their activity into a sustainable working group for ecology and workplace health, call upon the Special Rapporteur and UN member States to closely monitor cases of stray vessels with hazardous wastes and materials, as a safety measure, in order to safeguard shipyards workers' health.
